- HCZ raises academic achievement standards in a section of Harlem through a combination of children's education programs, healthcare provision, employment training, and other social services.
- "Promise Neighborhoods": 20 locations to replicate HCZ model, funded 50/50 by federal government and private sources
- \$10 million set aside by Obama Administration for 2010
